- F) Continuing to mow properties.
- G) Ran sewer Jetter at Washington Townhouses.
- H) Repairing yards from leaks.

GENERAL BUSINESS:

- A) Moved by Roger Martin, seconded by John Sines that all bills be approved as reviewed by management and the Board, in addition to all fund transfers as presented. Passed unanimously.
- B) Lake Washington Club Sewer Project The Infrastructure & Jobs Development Council approved the project yesterday to move forward. The next thing that has to happen is a request for a binding commitment letter from them. We will then be able to go to the PSC with our filing. The Wood County Commission has offered their assistance to the project.
- C) Wadesville Water project The District has our paper work at the PSC and they are reviewing it. Still no idea of how long the process will take.
- D) Ball School Road Water project We received paper work from the PSC today saying that staff did not have a problem with the project as submitted and that there was no need for a Certificate of Convenience and Necessity. We now wait on PSC Commissioners to make their ruling.
- E) Corp of Engineers work at the wellfield. We are in the 30 day comment period on the revised Environmental Report.
- F) Moved by John Sines, seconded by Roger Martin that the District approve Payment #2 to Central Painting & Sandblasting, Inc. in the amount of \$68,575.72 for work on the Homewood Storage Tank.
- G) Roger Amos On the advice of council and past history there is no ability for the District to get involved. Jim is directed to write a letter to Mr. Amos.
