BUSINESS: Prayer by Jerry Martin with Pledge following.

- A) Moved by Roger Martin, seconded by John Sines that the minutes of the Board meeting of October 14, 2010 be approved. Passed unanimously.

DISCUSSION OF DISTRICT HAPPENINGS:

It was reported what has been happening in the District:

- A) Installed 0 water taps since the last Board meeting. There are 0 water taps to be installed. This gives us 13 water taps for 2010. The District has installed 0 sewer taps since the last Board meeting. There are 0 sewer taps to be installed. This gives us 3 sewer taps for 2010.
- B) Worked on the reduction valve.
- C) Repaired 1 service line and 3 main line leaks.
- D) Completed work orders, spotted lines, set meters.

GENERAL BUSINESS:

- A) Moved by Roger Martin, seconded by John Sines that all bills be approved as reviewed by management and the Board, in addition to all fund transfers as presented. Passed unanimously.
- B) Lake Washington Club Sewer Project – The District continues to wait on the PSC to give us a staff recommendation. The ALJ has set a timeline for everyone that includes a hearing, if needed, for December 14, 2010.
- C) Wadesville Water Project – We are waiting on Harry at Rural Utility Service to be satisfied that all of the changes that B & N has made to the plans and specs are OK before they will let us advertise. Moved by Roger Martin, seconded by John Sines that the District advertise for bids as soon as the Rural Utilities Services gives the District permission. Passed unanimously.
- D) Ball School Road Water Project - The guys are finally out of the rock and hillside and are beginning to get some footage in the ground. They have gotten about 3,500 feet in so far.

E) Tank Painting Project

1. Moved by John Sines, seconded by Roger Martin that the District authorize payment of \$35,253 as listed in Payment Request No. 5. Secondly, the payment of \$9,030.10 will be made upon the State of West Virginia giving the District authorization to release their final payment due to the tax situation. Passed unanimously.



3. Moved by Roger Martin, seconded by John Sines that the District approve Change Order No. 1 and Final Balancing for the Tank Painting Project to change the contract amount to \$361,200. Passed unanimously.


