DISCUSSION OF DISTRICT HAPPENINGS:



It was reported what has been happening in the District:

- A) Installed 0 water taps since the last Board meeting. There are 0 water taps to be installed. This gives us 1 water tap for 2011. The District has installed 0 sewer taps since the last Board meeting. There are 0 sewer taps to be installed. This gives us 1 sewer tap for 2011.
- B) Repaired 0 service line leaks and 0 main line leaks.
- C) Changing meters.
- D) Put down gravel at the well field.
- E) Checked sewer complaint in Lubeck Hills. Appears to be customer problem. Also ran the smoker for a customer in Westwood. It is the customers problem.
- F) Completed work orders, spotted lines, set meters, etc.

GENERAL BUSINESS:

- A) Moved by Roger Martin, seconded by John Sines that all bills be approved as reviewed by management and the Board, in addition to all fund transfers as presented. Passed unanimously.
- B) Moved by Roger Martin, seconded by John Sines that the Board approve the revision to the engineering agreement for the Wadesville Water Project contingent upon approval of the Rural Utilities Services.
- C) Ball School Road Water Project–We continue to work on laying pipe for this project. Had a delay in pipe laying because of the State Road wanting the ditches cleaned out.
- D) Moved by Roger Martin, seconded by John Sines that the District accept the 3.4% rate increase for the sewer department as proposed by the Public Service Commission. Passed unanimously.

- E) John Tebay asked about listing the parcel of property at Pahlhurst Plaza in an effort to get it in the listing book along with the front property owned by Mr. Kincaid. Mr. Kincaid is not interested in purchasing our property. Jim is to do some checking to see if the property can be listed.
- F) Moved by Roger Martin, seconded by John Sines that the District accept the February 2011 financial statements as prepared by Philip R. Postlewait, Jr., CPA. Passed unanimously.
