BUSINESS: Prayer by Jerry Martin followed by the Pledge.

- A) Moved by Roger Martin, seconded by John Sines that the minutes of the Board meeting of July 14, 2011 be approved. Passed unanimously.

DISCUSSION OF DISTRICT HAPPENINGS:

It was reported what has been going on in the District:

- A) Installed 0 water taps since the last Board meeting. There are 3 water taps to be installed. This gives us 30 water taps for 2011. Installed 0 sewer taps since the last Board meeting. The District has 0 sewer taps to be installed. This gives us 1 sewer tap for 2011.
- B) Repaired 1 main line and 5 service line leaks.
- C) Worked on a hydrant on Lost Payment.
- D) Working on cleanup of Ball School and Lost Pavement.
- E) Laying line on Lost Pavement.
- F) Mowing of all properties.
- G) Clean up of properties due to leaks.
- H) Completed work orders, spotted lines, set meters.

GENERAL BUSINESS:

- A) Moved by Roger Martin, seconded by John Sines that all bills be approved as reviewed by management and the Board, in addition to all fund transfers as presented. Passed unanimously.
- B) Lake Washington Club Sewer Project: Still waiting on the PSC. Final recommendation will be announced by August 12, 2011.
- C) Wadesville Water Project – Contractor has completed laying water mains. He will be completing the remainder of his taps and working on cleanup. We are now waiting on Rural Development Engineer to approve Change Order #2 Buck Run & Lost Pavement. Mineral Wells PSD has called and told the District that they are not interested in spending the money to make a connection with Lubeck. We have asked Mineral Wells to send us a letter so stating.

1. Moved by Roger Martin, seconded by John Sines that the District approve the revised Legal Agreement for Mr. Myers for a maximum cost of \$7,386.70. Passed unanimously.
2. Moved by Roger Martin, seconded by John Sines that the District approve Pay Request No. 5 in the amount of \$228,167.56 which comprises of Stonegate Construction for \$177,921.66 and Burgess & Niple for \$50,245.90. Passed unanimously.
3. Moved by Roger Martin, seconded by John Sines that the District approve Change Order No. 3 for the Addition of line on Orem Road totaling \$102,828.50. Passed Unanimously.

D) Ball School Road Water Project – Continue to install pipe.

E) Belleville Water Project – Had a meeting with Keith Burdette, WV Development Office, he advised us to include water samples in a revised SCBG Application that shows health issues.


F) Moved by Roger Martin, seconded by John Sines that the District go into Executive Session to discuss Employee matters. Passed unanimously.
