- D) Wadesville Water Project- Work is proceeding; the engineers have begun design work for Locust Ridge Rd. The District will begin working on obtaining Easements for this part of the Project. No time frame has been established at this point in time. Moved by John Sines seconded by Jerry Martin that the District pay Stonegate Construction Inc. \$94,176.74 for Payment # 11. Burgess & Niple \$26,288.00 for invoice 485470, and Rural Development \$42,000.00 for first year's interest on loan 91-05, and \$3,500.00 for March 11<sup>th</sup> monthly interest payment. Passed unanimously.
- E) Lost Pavement- Continuing to repair yards. Farm view Dr. is now complete, and we have 300 Ft left on Bobcat Hollow.
- F.) Utility Service Contract- still working on cost estimates for the media.

  Moved by Jerry Martin seconded by John Sines to table discussion until after meeting with Utility Service Contract Passed unanimously.
- G.) Water Rate Increase- District has proposed a 20% increase on water. Moved by Jerry Martin seconded by John Sines that the District ask for a 20% water rate increase from the Public Service Commission. Passed unanimously.
- H.) Belleville Water Project- Received permission letter form Mineral Wells to take over Pond Creek. There is no preliminary design from Cerrone to help speed up the process.
