LUBECK PUBLIC SERVICE DISTRICT BOARD MEETING MINUTES April 26, 2012

BUSINESS: Prayer by Jerry Martin. Pledge followed.

A.) Moved by Jerry Martin and seconded by John Sines that the minutes of the Board meeting of April 12, 2012 be approved. Passed unanimously It was also moved by John Sines to accept the minutes of two special meetings. One on the 15th of March and the other on the 23rd of March. Motion was second by Jerry Martin and the motion carried unanimously.

DISCUSSION OF DISTRICT HAPPENINGS:

It was reported what has been going on in the District:

- A.) Installed 11 water taps since the last Board meeting. There are 2 water taps to be installed. This gives us 28 water taps for 2012. The District has installed 1 sewer tap since the last Board meeting. There is 1 sewer tap to be installed. This gives us 1 sewer tap for 2012.
- B.) Repaired 1 service line and 0 main line leaks.
- C.) Completed work orders, set meters, vehicles repairs, etc.
- D.) Working on Yard Repairs and mowing of property.
- E.) Repaired Flush Hydrant
- F.) Replaced a drain on Farmview Drive.
- G.) Repaired Blacktop on Whitman Addition

GENERAL BUSINESS:

- A.) Moved by Jerry Martin and seconded by John Sines that all bills be approved as reviewed by management and the Board, in addition to all fund transfers as presented. The motion passed unanimously.
- B.) Moved by John Sines and seconded by Jerry Martin that the District approve financial statements for February 2012 and March 2012 as presented by Phil Postlewait CPA. The motion passed unanimously.

C.) Lake Washington Club Sewer-

- There was a motion to accept a Jackson Kelley proposal to increase the contract for the bond Counsel to 30,000 dollars from 25,000,. due to additional unexpected work. Motion is made by Jerry Martin and second by John Sines. The motion carried unanimously.
- There was a motion by Jerry Martin to accept MOVRC to administer the Lake Washington project the motion was second by John Sines and the motion carried unanimously.
- There was a motion to accept an agreement for accounting services by Phillip Postlewait jr. CPA for the Lake Washington Club Sewer Project by Jerry Martin and the motion was second by John Sines. The motion carried unanimously.
- It was also moved by John Sines to accept a property procurement services agreement from Attorney, Blane Myers for the Lake Washington Club Sewer Project, not to exceed \$15,000.00. The motion was second by Jerry Martin and the motion carried unanimously.

D.) Wadesville Water Project-

- Punch list was completed on the Lost Pavement change order.
- Still waiting for DOT and DEP permits. Craig Richards, engineer for Burgess and Niple told the board that they expected to get DOT approval in the coming week. There is also a Soil Erosion Permit that is outstanding from the DEP.
- A motion was made by Jerry Martin and second by John Sines to accept a pending change order to install the Locust Ridge Change Order not to exceed \$85,000. The motion carried unanimously.
- E.) Utility Service Contract- Blain Meyers has drafted a letter to this company. I have been in contact with this company and I have not heard from them back. Jerry Martin made a motion to modify the letter and send it on to Utility Service Company. The motion was second by John Sines and passed unanimously.
- F.) Ed Hupp, Director for Wood County Emergency Management and Captain Rick Woodyard with the Wood County Sheriff's office made a request to use our water towers to install microwave transmitters for improved

communication for police and fire. Captain Woodyard also told the commissioners that the district could benefit by being able to piggy back their system for communications, telemetry and internet connect ability. He also said that the district would be held harmless from any damage to equipment or accidents that may occur due to the installation of these microwave transmitters. Jerry Martin made a motion to allow the microwave dishes to be installed under the above conditions the motion was second by John Sines and it carried unanimously.

- G.) Belleville Water Project- There was a brief update of potential funding for this project.
