A.) Moved by Jerry Martin and seconded by John Sines that the minutes of the Board meeting of May 10, 2012 be approved. The motion passed unanimously.

DISCUSSION OF DISTRICT HAPPENINGS:

It was reported what has been going on in the District:

- A) Randy Atkinson reported for Rocky McConnell the following crew activities.
 - Installed 0 water taps since the last Board meeting. There are 2 water taps to be installed. This gives us 31 water taps for 2012. The District has installed no sewer taps since the last Board meeting. There are no sewer taps to be installed. This gives us a total of 1 sewer tap for 2012.
