BOARD MEETING MINUTES June 28th, 2012

BUSINESS: Prayer by Jerry Martin. Pledge followed.

A.) Moved by Jerry Martin and seconded by John Sines that the minutes of the Board meeting of June 14th, 2012 be approved. The motion passed unanimously.

DISCUSSION OF DISTRICT HAPPENINGS:

It was reported what has been going on in the District:.

- Installed 4 water taps since the last Board meeting. There are 5 water taps to be installed. This gives us 38 water taps for 2012. The District has installed no sewer taps since the last Board meeting. There are no sewer taps to be installed. This gives us a total of 1 sewer tap for 2012.
- Repaired 6 service line and 1 main line leaks.
- Completed work orders, set meters, vehicles repairs, etc.
- Working on Yard Repairs and mowing of property.

GENERAL BUSINESS:

- A.) Moved by John Sines and seconded by Jerry Martin that all bills be approved as reviewed by management and the Board, in addition to all fund transfers as presented. The motion carried unanimously.
- B.) A motion was made by Jerry Martin to move \$18,000 .00 from excess reserve funds held at the Municipal Bond Commission to the active account operations account. Motion was seconded by John Sines and the motion carried unanimously.

C.) Lake Washington Club Sewer-

 It was reported that the preconstruction meeting was held for the Lake Washington Club Sewer System Project with 20 attendees representing project engineer, Mid-Ohio Valley Regional Council, Tri State Pipeline, Residents of Lake Washington Club, WVDEP and WVDEP Dam Safety. Details of the project were discussed and though the Notice to proceed is set for July 9th the contractor is targeting July 15th for the actual start date.

D.) Wadesville Water Project-

• It was reported that change order #4 is under construction 570lf had been laid and a fire hydrant had been set.

G.) Belleville Water Project-

 No new news concerning Belleville project. Funding was discussed and so was the contact that the Belleville residents have had with their representatives with very few replies. The board directed Manager Randall Atkinson to follow up with the representatives offices with a telephone call to find out to where in the process the requests have progressed.

E.) Public discussion

 Residents of Lubeck Hills discussed concerns about failing individual sewer systems in their neighborhood and what Lubeck PSD might to do help with this situation.
