#### **BOARD OF COMMISSIONERS MEETING**

Chairman, Tingler called the meeting to order.

Secretary Deem read the minutes from the previous meeting. Chairman Tingler asks for any comments or corrections. A motion to accept the minutes as presented was made by Commissioner Hoffman and seconded by Commissioner Deem, Motion passed unanimously.

Chairman Tingler asked for a motion to approve and accept the meeting agenda. A motion made by Commissioner Hoffman and seconded by Commissioner Deem passed unanimously.

**<u>Disbursements</u>**: The July 2020 disbursements, were reviewed and initialed by all commissioners.

Questions and Comments from the Public: There were none.

#### **Old Business:**

### Sewage Plant Upgrade and Central Sewer Extension:

Mr. Brabham present to the board for consideration a resolution authorizing payment for equipment purchased from Core & Main in the amount of \$14,892.00. A motion to approve was made by Commissioner Hoffman and seconded by commissioner Deem, passed unanimously.

Water Rate Review: Mr. Allen reported the PSC approved tariff is now in effect and the new rates will be on the August billing.

New Business: There were none.

#### **Miscellaneous:**

Mr. Brabham reported that the sewer system was running as normal. A water booster pump failed and the replacement pump has been ordered.

Mr. Brabham provided an update on the property damage to the districts vacuum station building that was struck by a vehicle on July 17, 2020. The insurance has authorized repair and the contractor is expected to start in the next few weeks.

Mr. Brabham discussed the 'DRAFT" 2019 Audit prepared by Lowe & Associates. Once the management rep letter was received, the Final 2019 Audit would be issued.

Chairman Tingler asked if there were any further business to come before the Board. A motion made by Commissioner Deem and seconded by Commissioner Hoffman to adjourn passed unanimously and the meeting was adjourned at 4:24 PM.
