<u>Questions and Comments from the Public</u>: Marie Leadmon of The Little Kanawha Service Company was in attendance inquiring on a status of the District taking ownership of the LKSC's water system. Todd Grinstead, General Manager of the District reported that all necessary paperwork requesting the transfer has been filed with the PSC.

Old Business:

Riser Ridge / laurel Fork Water Extension Project: Mr. Grinstead presented to the Board requisition No.26 in the amount of \$57,524.11 a motion made by Commissioner Law and seconded by Commissioner Summers passed unanimously.

Newark Area Sewer System Project: Mr. Grinstead presented to the Board an engagement letter for Bennett & Dobbins Accountants to complete and submit the project Rule 42 documents. A motion made by Commissioner Law and seconded by Commissioner Miller passed unanimously.

Sewer Rate: Mr. Grinstead reported the District is waiting approval from the Public Service Commission. PSC staff will be on site Monday May 20, 2013 to review our books.

Little Kanawha Service Company Wastewater System: Mr. Grinstead reported that all necessary paperwork requesting the transfer has been filed with the PSC.

Wood County Parks & Recreation Wastewater System: Mr. Grinstead reported the District began operation of the system on May 1, 2013.
