Chairman Miller asked if there were no objections, the Board would dispense with the reading of the minutes from the previous meeting, there were no objections. A motion to accept the minutes as presented was made by Commissioner Law and seconded by Commissioner Summers Motion passed unanimously

Old Business:

Newark Area Sewer System Project: Luke Peters of the MOVRC, presented to the Board drawdown No.17 for \$75,465.96 a motion made by Commissioner Law and seconded by Commissioner Summers to approve the draw down passed unanimously.

Mr. Grinstead presented the Board with an addendum to the Engineering agreement for Cerrone Associates. The agreement extends inspection services through the end of the extended project. The agreement allows for a not to exceed amount of \$10,000. A motion made by Commissioner Law and seconded by Commissioner Summers to approve the addendum as presented passed unanimously.

2015 Water Systems Improvement Project: Luke Peters of the MOVRC, presented to the Board drawdown No.2 for \$230,782.20 a motion made by Commissioner Summers and seconded by Commissioner Law to approve the draw down passed unanimously.

Water Bond Refunding: Nothing at this time

<u>New Business:</u> Mr. Grinstead briefed the Board on the financial condition of the Districts sewer accounts. After discussion, a motion made by Commissioner Law and seconded by Commissioner Summers to prepare the necessary information and schedule a working secession with the Wood County Commission passed unanimously.

<u>Miscellaneous:</u> Mr. Grinstead presented to the Board the voting credential form for the 2016 West Virginia Rural Water Association annual business meeting. A motion made by Commissioner Law and seconded by Commissioner Summers to appoint Shayne Brabham as the Districts voting delegate and Todd Grinstead as the alternate Delegate passed unanimously.

Mr. Brabham reported the District had repaired one water main break, one service line leak and installed three new water services in June 2016.

Chairman Miller asked if there were any further business to come before the Board. A motion made by Commissioner Law and seconded by Commissioner Summers passed unanimously, and the meeting was adjourned at 3:07 p.m.
