Chairman Miller asked if there were no objections, the Board would dispense with the reading of the minutes from the previous meeting, there were no objections. A motion to accept the minutes as presented was made by Commissioner Law and seconded by Commissioner Summers Motion passed unanimously

Chairman Miller asked for a motion to approve and accept the meeting agenda. A motion made by Commissioner Law and seconded by Commissioner Summers passed unanimously.

**Disbursements**: The March 2017 disbursements were reviewed and initialed by all commissioners.

Questions and Comments from the Public There were none.

#### Old Business:

**Newark Area Sewer System Project**: Mr. Luke Peters of the MOVRC is working to finalize administratively to work toward project construction close out.

2015 Water Systems Improvement Project: Mr. Luke Peters of the MOVRC, presented to the Board drawdown No.11 for \$160,867.25. A motion made by Commissioner Law and seconded by Commissioner Summers to approve the draw down passed unanimously.

Mr. Grinstead presented to the Board Change Order for Contract No.1, for \$21,000 for final adjustments to the original scope of work, Additional Mobilization for Kinchloe Road extension, additional walkway for raw water generator, and to complete asphalt repairs on Stillwell Road. A motion made by Commissioner Summers and seconded by Commissioner Law passed unanimously.

Mr. Grinstead presented to the Board Change Order No.3 for Contract No.2, for an increase contract cost of \$8,540. To receive credit from the elimination of a control vault at the Dutch Ridge tank and install security fence at the Raw water intake control structure and the Grieves Run water booster station. A motion made by Commissioner Summers and seconded by Commissioner Law passed unanimously.

<u>Sewer Division Rate Review:</u> Mr. Grinstead reported to the Board that the District staff is continuing to preparing for a working meeting with the Wood County Commission.

New Business: Nothing at this time.

<u>Miscellaneous:</u> Mr. Brabham reported the District had installed 2 water taps and repaired 1 service line leaks in March 2017.

Chairman Miller asked if there were any further business to come before the Board. A motion made by Commissioner Law and seconded by Commissioner Summers to adjourn the meeting passed unanimously, and the meeting was adjourned at 3:08 p.m.
