### BOARD OF COMMISSIONERS MEETING

DATE: October 10, 2017

OTHERS IN ATTENDANCE: Todd Grinstead, General Manager, Shayne Brabham, Assistant Manager, A.J. Allen, Office Manager. Meganne Robinson of the Mid-Ohio Valley Regional Council (MOVRC). Robert Lowe, Wirt County Commissioner.

Michael Miller, Chairman, presided. The Chairman called the meeting to order.

Chairman Miller asked if there were no objections, the Board would dispense with the reading of the minutes from the previous meeting, there were no objections. A motion to accept the minutes as presented was made by Commissioner Summers and seconded by Commissioner Law passed unanimously.

Chairman Miller asked for a motion to approve and accept the meeting agenda. A motion made by Commissioner Summers and seconded by Commissioner Law passed unanimously.

<u>Disbursements</u>: The September 2017 disbursements were reviewed and initialed by all commissioners present.

<u>Questions and Comments from the Public</u> Wirt County Commissioner Robert Lowe was present to obtain information pertaining to the pending sewer rate case.

#### **Old Business:**

<u>Sewer Division Rate Review:</u> Chairman Miller ask Commissioner Law to read for its second time, the resolution to change the sewer rates of Claywood Park PSD as prepared by Attorney James Kelsh. Commissioner Law read the resolution aloud. Time was scheduled to allow for customers an opportunity to ask questions and voice concerns. There were no customers present. A motion made by Commissioner Summers and seconded by Commissioner Miller, to accept the resolution as read passed unanimously.

**Newark Area Sewer System Project**: Meganne Robinson of the MOVRC, presented to the Board drawdown No.24 for \$320.45. A motion made by Commissioner Summers and seconded by Commissioner Law to approve the draw down passed unanimously.

**2015 Water Systems Improvement Project:** Meganne Robinson of the MOVRC, presented to the Board drawdown No.15 for \$97,291.29. A motion made by Commissioner Law and seconded by Commissioner Summers to approve the draw down passed unanimously.

<u>New Business</u>: Mr. Grinstead reported to the Board he had received a request to extend water lines to approximately 20 homes in the Borland Springs area of Wood County, and he also received a request to extend water lines to approximately 40 homes in the Freeport area of Wirt County. Mr. Grinstead stated he had been in contact with the Districts Engineer to begin to explore the feasibility of serving these areas.

Miscellaneous: Commissioner C. Randall Law presented to Chairman Miller a letter stating that he will be resigning as commissioner of the Claywood Park Public Service District effective October 31, 2017. Commissioner Law stated "It has been a pleasure to work with everyone for the betterment of the water and sewer customers in our District". Commissioner Law has served on the Board for 19 years. Staff and Board members wished him well in his future.

Mr. Brabham reported the District had installed 3 new water taps and repaired three service line leaks, in September 2017.

Chairman Miller asked if there were any further business to come before the Board. A motion made by Commissioner Law and seconded by Commissioner Miller to adjourn the meeting passed unanimously, and the meeting was adjourned at 7:45 p.m.
