Consideration of and final action on a Bond Resolution (the "Bond Resolution") authorizing the issuance of not to exceed \$2,800,000 in aggregate principal amount of the Claywood Park Public Service District Water Refunding Revenue Bonds, Series 2021 A (the "Bonds") to refund all or a portion of the District's Water Revenue Bond, Series 2008, to fund a debt service reserve fund for the Bonds and to pay costs of issuing the Bonds and related costs.

#### **BOARD OF COMMISSIONERS MEETING**

Michael Miller, Chairman, presided. The Chairman called the meeting to order.

Chairman Miller asked if there were no objections, the Board would dispense with the reading of the minutes from the previous meeting, there were no objections. A motion to accept the minutes as presented was made by Commissioner Cox and seconded by Commissioner Summers passed unanimously.

#### **Old Business:**

#### Water Revenue Bond Refinance-Series 2008

Mr. Steptoe, Crews & Associates, recommended to the board, a modified plan that would net the district additional savings than what was proposed in December. The proposal would require the district to obtain a bond insurance policy along with a surety bond which would allow the bond package to be more attractive to potential investors. After discussion, the board directed that Cam Siegrist, bond counsel and Robert Steptoe, Crews & Associates, to begin obtaining an insurance application and to proceed with the new bond proposal.

#### Freeport Area Waterline Extension Project:

Mr. Brabham reported that project material was being delivered in the next week and weather permitting, the contractor could start construction by the end of January.

#### Newark Sewer Phase II / Spring Valley Sewer Project:

Mr. Brabham reported that due to the COVID-19, it has made obtaining rights-of-ways difficult in meeting with customers. A project team conference call is scheduled for January 19, 2021 and hope to

receive more information regarding the SHPO clearance needed to proceed with securing the remaining funds required.

## Miscellaneous:

Operations Report: Mr. Brabham reported that the district installed four water taps, repaired three water service line leaks and two main line leaks.

Chairman Miller asked if there were any further business to come before the Board. A motion made by Commissioner Summers and seconded by Commissioner Cox to adjourn the meeting, passed unanimously, and the meeting was adjourned at 3:28 p.m.
