Newark Sewer Phase II / Spring Valley Sewer Project:

Mr. Brabham provided a status update of the project. The line contractor has nearly all the gravity sewer installed in Contact 1. Awaiting the power company to install the electric. Contract 2 is nearing completion as well and is hopeful to be completed by the end of the year.

Mr. Brabham presented to the board for approval, Drawdown No. 9 in the amount of \$262,951.30. Dunlap Contracting LLC to receive \$214,728.92, Cerrone Associates, 46,609.70 and MOVRC, \$1,612.64. A motion to accept was made by commissioner Summers, seconded by commissioner Cox, passed unanimously.

Dutch Ridge Water Line/Meter Replacement Project

Mr Brabham reported that the pre-construction conference was held on November 6, 2024 at the district office. The contractor is preparing to start before the end of the year. Product submittals have been received by the engineer for review.

New Business:

Mr. Brabham presented to the board for approval the 2025 Employee Health Insurance Renewal Acknowledgement Letter. The 2025 premium was increased by six percent. A motion to approve was made by chairman Miller, seconded by commissioner Cox, passed unanimously.

Operations Report: Mr. Brabham reported that the district had five water main break, twelve service leaks and three new water tap installed.

Dutch Ridge Water Line Replacement Project Pre-Closing

Mr. Benasso, Bowles Rice LLP, presented to the board for consideration a bond resolution authorizing the issuance of \$940,000.00 in aggregate principal amount of the districts water revenue bond, series 2024, to finance the cost for the Dutch Ridge Water System Upgrade Project.
