# ORDINANCE SETTING FORTH AND ADOPTING RULES GOVERNING THE PUBLIC COMMENT PORTION OF WOOD COUNTY COMMISSION MEETINGS

## Wood County Commission Comment Policy

#### 1) GENERAL MATTERS

- a) **Presiding Officer** shall be the Commission President, in the event the President is absent then either of the other may preside over that meeting's comment period.
  - Maintaining Order-The following behaviors, <u>when they actually cause disruption of a</u> <u>meeting</u> are prohibited and provide grounds for the Presiding Officer to declare a speaker out of order. The Presiding Officer, with the assistance of the Wood County Sheriff's Department, may expel a person from any meeting if they refuse to cease their disruptive behavior and <u>may call for security to physically remove or arrest any persons who persist in</u> <u>actual disruption</u>. These types of disruptions may include but are not limited to:
    - (1) creating or participating in a physical disturbance,
    - (2) speaking out of turn or in violation of applicable rules (including time limits),
    - (3) preventing or attempting to prevent others who have the floor from speaking,
    - (4) preventing or impeding others from observing the meeting and
    - (5) entering into or remaining in an area of the meeting room that is not open to the public.
  - **ii)** Enforcement Disruptive behavior, as described more fully above, may result in removal from a meeting and/or arrest and prosecution.

#### 2) PUBLIC COMMENT:

#### a) Public Comment: General Rules

- i) Public comment will only be made under the Public Comment portion of the agenda.
- ii) There shall only be a period of public comment on the Monday meetings, in the event a Monday meeting is cancelled there will not be a public comment period for that week.
- iii) The public will not be permitted to ask questions or make comments during any other portion of the meeting, unless approved otherwise by the Commission President.
- iv) Any person desiring to address the Wood County Commission must first sign-in prior to the start of the meeting as outlined below.
- v) Sign-in Sheet Anyone wishing to speak during the public comment portion of a meeting must sign in. The Sign-in Sheet will be located at the table 15 minutes prior to the start of the meeting. When the meeting begins the sign-in sheet will be removed from the table and given to the Commission President. Once the Sign-in Sheet is removed from the table, the public is no longer able to sign-up for public comment.
- vi) Time Limits The time for public comment shall not exceed three (3) minutes per speaker unless more time is granted by majority vote of Commission.
- vii) The total time limit for the public comment portion of any meeting shall not exceed fifteen (15) minutes unless, more time is granted by the majority of the Commission.
- viii) Statements are to be directed to the Commission as a whole and not to individual members. Public comment does not require any member of the governing body to provide any answer to the speaker as it is not reasonable for the Commissioners to respond without any notice to research the issue.
- ix) A speaker may sign up only one time per each meeting and may not cede his or her time to another commenter.
- **x)** The Commission President will call each speaker who has signed in to the podium, and the speakers will state their name and addresses. The Commission President will then begin the timer.

- **xi)** The Wood County Commission complies with the *Open Governmental Proceedings Act* (WV Code §6-9A-1\_through 12) as set forth by the WV State Code.
- xii) Public Comments shall be recorded as part of the Commission meeting and thus shall be part of the official record so long as the Commission retains the recordings. The recording of all public comments is to be performed by the County Administrator.
