At 9:30 A.M., the County Commission of Wood County met in regular session. They signed purchase orders, invoices and other correspondence.

**AGENDA AND DISCUSSION ITEMS**

At 9:30 A.M., there were no public comments.

At 9:32 A.M., the County Commission approved the hiring of Audie Murphy as a Telecommunicator for the E-911 Center.

At 9:33 A.M., the County Commission discussed the ambulance calls for E-911 in the County with Dale McEwuen. He stated they need to add six ambulances to handle the traffic. He stated they need \$900,309.00 to make the purchase.

The County Commission of Wood County, upon a motion made by David Blair Couch, seconded by James E. Colombo, and made unanimous by Robert K. Tebay, did hereby AUTHORIZE the emergency purchase of six (6) used ambulances from St. Joseph's Ambulance Services. The said purchase is to enable WVU Camden Clark Emergency Ambulance Service.

Said need to purchase ambulances is the result of St. Joseph Ambulance Services notifying the Wood County Commission that they will cease operations on March 31, 2025 and will no longer be responding to E911 emergency calls. (Order C/241)

The County Commission of Wood County was in receipt of a New Road Name Request Form from AFGH LLC, to name a road to their property COUNTRY RIDGE ROAD. The said Request does not interfere with the scheduled readdressing and mapping for the E-9-1-1 Master Street Addressing Guide. The road to be known as COUNTRY RIDGE ROAD is located on the right off Happy Hollow Road, ½ mile off Deerwalk Highway, in Union District, Tax Map 231, Parcel 008. The request by AFGH LLC is in accordance with Chapter 7, Article 1, Section 3 of the Code of West Virginia, 1931, as amended, which deals, in part, with the County Commission naming or renaming thereof of roads, ways, streets, avenues, drives and the like to assure uniform, nonduplicative conversion of all rural routes to city-type addressing on a permanent basis. The County Commission does hereby find that the said request, made in writing, by AFGH LLC, and the approval from the Wood County E-9-1-1, is in proper form and is hereby ORDERED to be filed. The County Commission of Wood County, upon a motion made by James E. Colombo, seconded by Robert K. Tebay and made unanimous by David Blair Couch, does hereby ORDER that the aforementioned road be named COUNTRY RIDGE ROAD. The County Commission does further ORDER that a copy of this ORDER, along with the New Road Name Request Form, be certified by the Clerk of the County Commission for entry in the Office of the Clerk of the County Commission. At 9:54 A.M., the County Commission met with Toni Tiano, Wood County Grant Writer and Hernando Escandon from the Wood County Day Report Center. They requested they apply for the annual grant to manage their programs. the County Commission of Wood County, upon

a motion made by David Blair Couch, seconded by James E. Colombo and made unanimous by Robert K. Tebay, did hereby AUTHORIZE James E. Colombo, in his official capacity as President Pro Tem and on behalf of the County Commission, to EXECUTE an Application for a Community Corrections Grant with the West Virginia Division of Justice and Community Services. Said grant application is in the amount of five hundred thousand dollars and zero cents (\$500,000.00) and is on behalf of the Mid-Ohio Valley Day Report Center. (Order A/3124)

At 10:01 A.M., Wood County Clerk, Joe Gonzales, met with the Commission to inform them of a property owner in Mountwood Park who wants to donate thirty-two (32) acres to the County and sell a remaining piece to them.

The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by James E. Colombo and made unanimous by David Blair Couch, did hereby Authorize the purchase of approximately eleven (11) acres of land located in Mountwood Park at Map 100, Parcel 000J 0000 0000 in Walker Taxing District. Said purchase is at a cost of fifteen thousand dollars and zero cents (\$15,000.00) from the Motley Survivors Trust. Further, the County Commission Authorized receiving 32.41 acres of land adjacent to said parcel as a donation to the County. (Order A/3126)

At 10:10 o'clock A.M., upon motion of David Blair Couch, seconded by James E. Colombo and made unanimous by Robert K. Tebay, County Commissioners, upon prior adjournment of the regular session, convened in EXECUTIVE SESSION upon authority granted by the West Virginia Code, Chapter 6, Article 9A, Section 4, as amended. WHEREUPON, the said Robert K. Tebay, James E. Colombo and David Blair Couch, County Commissioners met with Marty Seufer, County Administrator, Joe Gonzales, Wood County Clerk, and Wood County

Sheriff, Rick Woodyard. All those present proceeded to discuss the matter for which the said EXECUTIVE SESSION was had, regarding investment of public funds. The Commission having concluded said discussion, the said EXECUTIVE SESSION adjourned at 10:17 o'clock A.M. (Order C/240)



## AGREEMENT CONTINUING

### THE MID-OHIO VALLEY REGIONAL DAY REPORT CENTER

WHEREAS, the Wood County Commission and the local Community Criminal Justice Board desire to continue their Community Corrections Program, which operates pursuant to WV§62-11c-1, et seq.;

WHEREAS, the Wood County Commission and the local Community Criminal Justice Board have met and agreed to continue the Mid-Ohio Valley Regional Day Report Center, pursuant to WV§62-11c-1, et seq.;

WHEREAS, the Wood County Commission entered into a Memorandum of Understanding for the purposes of submitting a grant application for the Fiscal Year 2025 to the West Virginia Division of Justice and Community Services for the continuation of the services which have previously been rendered in Wood, Jackson, Pleasants, Ritchie, and Roane Counties, under the name Mid-Ohio Valley Regional Day Report Center.

WHEREAS, the Wood County Commission, Jackson County Commission, Pleasants County Commission, and Ritchie County Commission have previously endorsed a Community Corrections Program, and have allotted funds with respect to its budget and operation of said programs;

NOW, THEREFORE, the undersigned for and on the behalf of the Wood County Commission and the local Community Criminal Justice Board agree to the following:

1. The Wood County Commission and the local Community Criminal Justice Board agree to continue the existence of the Mid-Ohio Valley Regional Day Report Center, pursuant to WV§62-11c-5;
2. The Community Corrections program shall be named and conduct business as the Mid-Ohio Valley Regional Day Report Center.
3. The Wood County Commission shall serve as the designated grantee for the grant submitted for the Fiscal Year 2026 to the West Virginia Division of Justice and Community Services and all future grants to ensure continuity of the program;
4. The local Community Criminal Justice Board designates the Wood County Commission as the fiscal agent for the Mid-Ohio Valley Regional Day Report Center;
5. All employees of the Mid-Ohio Valley Regional Day Report Center shall be co-employees of the Mid-Ohio Valley Regional Day Report Center and the Wood County Commission. As such, all employee payments, withholding, matching taxes and fringe benefits and insurance shall be paid by and through the Wood County Commission.
6. The local Community Criminal Justice Board shall remain in effect for the Mid-Ohio Valley Regional Day Report Center, pursuant to WV§62-11c-6;
7. That the local Community Criminal Justice Board shall meet as stipulated by the current bylaws and/or as needed;
8. The local Community Criminal Justice Board shall consist of the following voting members:
  - a. The sheriff or chief of police or, if the board represents more than one county or municipality, at least one sheriff or chief of police from the counties represented;
  - b. The prosecutor or, if the board represents more than one county, at least one prosecutor from the counties represented;
  - c. If a public defender corporation exists in the county or counties represented, at least one attorney employed by any public defender corporation existing in the counties represented or,

if no public defender office exists, one criminal defense attorney from the counties represented;

d. One member to be appointed by the local board of education or, if the board represents more than one county, at least one member appointed by a board of education of the counties represented;

e. One member with a background in mental health care and services to be appointed by the commission or commissions of the county or counties represented by the board;

f. Two members who can represent organizations or programs advocating for the rights of victims of crimes with preference given to organizations or programs advocating for the rights of victims of the crimes of domestic violence or driving under the influence; and

g. Three at-large members to be appointed by the commission or commissions of the county or counties represented by the board.


A. At the discretion of the West Virginia supreme court of appeals, any or all of the following people may serve on a community criminal justice board as ex officio, nonvoting members:

- (1) A circuit judge from the county or counties represented;
- (2) A magistrate from the county or counties represented; or
- (3) A probation officer from the county or counties represented.

- 9. The Wood County Commission, Jackson County Commission, Pleasants, County Commission, and Ritchie County Commission agree that maintaining an equal number of representatives from each county on the Community Criminal Justice Board is not necessary.
- 10. The local Community Criminal Justice Board will provide oversight for the overall direction of the Mid-Ohio Valley Regional Day Report Center and issue recommendations to the Wood County Commission pertaining to the hiring or firing of a Director for the Mid-Ohio Valley Regional Day Report Center;
- 11. The Director of the Mid-Ohio Valley Regional Day Report Center will administer the day-to-day operations of the program, including, but not limited to, the following: hiring and firing of employees, budgetary expenditures, supervision of offenders, treatment protocol, interaction with the judicial system, data collections, grant applications, and grant reimbursement requests.
- 12. Any modification of this Agreement must be in writing and signed by the president of the Wood County Commission and the Chair of the local Community Criminal Justice Board.
