At 10:06 A.M., Jeremy Cross, Mountwood Park Director, met with the County Commission to let them know there are four different events going on at the park this weekend.

Commissioners,

It was my pleasure to address you at the commission meeting held on February 4th. As stated we are trying to regroup and recruit for the coming fiscal year. As part of the spring inspection of the cannon and limber we found 3 wheels that needed attention. These three wheels are about 8 years old each.







We keep both pieces in a garage, provided for us at no cost, by a friend of the Battery, in Belpre. These types of wheel problems come up over time. Sometimes we can have parts replaced and have them put back together for a serviceable wheel. However as these three are nearing 8 years of service, it is felt that purchasing new wheels would be more expedient than to keep replacing pieces in the long run.

A new wheel with axel insert is quoted as costing about \$950.00 each. We have checked one of the wheels and feel it can make through another season of reenacting. We have enough in our account to cover this cost, pay for the gas, food and lodging, but when finished our funds will be greatly depleted. These were funds you allotted for Uniform and Equipment replacement.

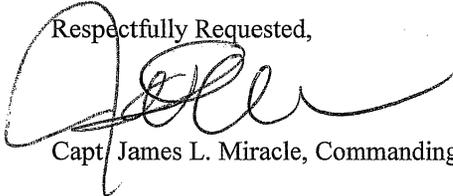
We, Carlin's Battery D, respectfully request an additional allotment \$2,000.00 to cover the cost of the new wheels and associated cost.

We had 18 persons attend, of which 14 were new Cannoneers, This group belonged mostly to the Point Pleasant and Wood County, Sons of the American Revolution groups.
