



**RESOLUTION DECLARING THE WEEK PRECEDING JUNE 28-29, 2025, AS  
AS AMATEUR RADIO WEEK IN WOOD COUNTY, WV**

WHEREAS, each year, the week preceding the fourth full weekend of June, shall be designated as "Amateur Radio Week" in the County.

WHEREAS, the Wood County Commission and public service and safety officials and their staff have come to understand the importance and reliability of ham radio to provide backup emergency communications during natural disasters and other emergencies.

WHEREAS, the Wood County Commission understands the significance of having qualified Federally-licensed ham operators who commit, volunteer and serve.

WHEREAS, the County's E-911 Center now provides space and equipment to qualified, trained amateur radio operators when they are needed and assigned.

WHEREAS, the observance of "Amateur Radio Week" will be combined with The American Radio Relay League Field Day event, a national exercise of preparedness, that is always conducted on the Saturday and Sunday of the fourth full weekend of June.

WHEREAS, the Wood County Commission appreciates the officers and the membership of the Parkersburg Amateur Radio Klub (P.A.R.K.) and Wood County Emergency Communications (WCEC).

WHEREAS, these two groups will culminate "Amateur Radio Week" by joining the ARRL Field Day, June 28-29, 2025, from 1800 UTC on Saturday until 2059 UTC on Sunday.


