Commissioner Colombo gave an update on a Wood County Recreation Commission meeting he attended.

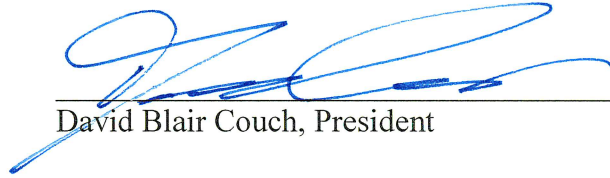
Having no scheduled appointments or business to attend to, the County Commission adjourned at approximately 10:20 A.M.
