Having no scheduled appointments or business to attend to, the County Commission adjourned at approximately 11:09 A.M.

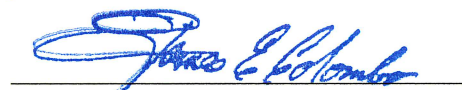
