The County Commission of Wood County met in regular session. They signed purchase orders, invoices and other correspondence.

AGENDA AND DISCUSSION ITEMS

At 9:36 A.M., Sam Scalise was approved as the Assistant Emergency Services Director. He also took his oath of office.

At 9:41 A.M., the County Commission approved the hiring of Trevor Cross as a Maintenance Department employee.

At 9:45 A.M., the County Commission held a hearing in regard to the Estate of Gladnalene Bell. Curtis Miller, Petitioner, was present to question the validity of the second Last Will and Testament recorded on April 21, 2025 by Tabatha Z. Boston. After discussion, the County Commission, upon a motion made by David Blair Couch, seconded by James E. Colombo and passed, Ordered that George Chandler be appointed Fiduciary Commissioner. (Probate Order)

At 10:08 A.M., the County Commission of Wood County, upon a motion made by David Blair Couch, seconded by James E. Colombo and passed, placed the name of Jeff Morrison in

nomination to fill a vacancy on the Wood County Fire Board, as authorized in West Virginia State Code 7-17-6. (Order A/3302)

At 10:09 A.M., the County Commission, upon a motion made by David Blair Couch, seconded by James E. Colombo and passed, did hereby APPOINT Brannon Turner, as a LITTER CONTROL OFFICER for Wood County, pursuant to Chapter 7, Article 1, Section 3ff of the Code of West Virginia, 1931, as amended. (Order C/301)

At 10:15 A.M., the County Commission held a hearing in regard to the Barbara E. Sullivan Estate. The Parkersburg Area Community Foundation & Regional Affiliates requested the Executrix, Chelsey Fiore-Hinkle, be removed. After discussion, the County Commission, upon a motion made by David Blair Couch, seconded by James E. Colombo and passed, Ordered the request be denied. (Probate Order).

At 10:30 A.M., the County Commission held a hearing in regard to the Darrell Williams Estate. Jeremy Williams, Executor, requested to be removed as Executor for personal reasons and requested that Tim Baer be appointed as the Administrator. After discussion, the County Commission, upon a motion made by David Blair Couch, seconded by James E. Colombo and passed, Ordered that Tim Baer be appointed as Administrator to finalize the Estate. (Probate Order)

At 10:45 A.M., Mark Schwendeman from Schwendeman Insurance met with the Commission to update the County employee insurance.

The County Commission, upon a motion made by David Blair Couch, seconded by James E. Colombo, passed and did hereby AUTHORIZE an increase of two and one-half percent (2-1/2 %) in the employee contribution for participation in the Health Insurance benefits. Said increase applies to all levels of participation. (Order C/303)

The County Commission sitting ex-officio, as the Board of Canvassers, reconvened at 11:00 P.M., to ascertain the results of the Canvass for the Primary Election held on May 12, 2026, in the County of Wood. Having carefully and impartially examined the returns of the aforesaid Election, and there being no contests pending, the Board of Canvassers, upon a motion made by David Blair Couch, seconded by James E. Hamric and made unanimous by James E. Colombo, does hereby CERTIFY the statewide and Wood County election results and do now declare the Canvass closed. The Clerk of the County Commission of Wood County is now directed to certify the results of said election to the Secretary of State, Charleston, West Virginia.

The County Commission, upon a motion made by David Blair Couch, seconded by James E. Hamric and made unanimous by James E. Colombo, does hereby adjourn as the Board of Canvassers, sine die.

Having no scheduled appointments or business to attend to, the County Commission adjourned at approximately 11:10 A.M.
