At 11:00 A.M., WVU Medicine representatives met with the County Commission and gave an update on the Ambulance Service.

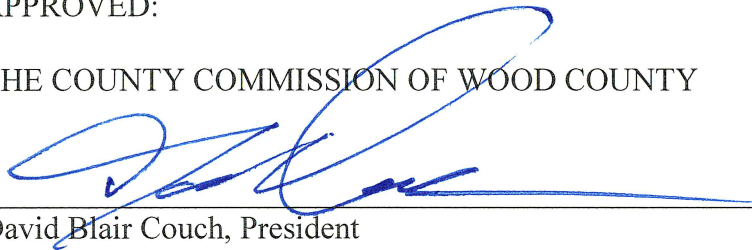
