Also in attendance was Mr. Benjamin McDay, Juvenile Service Specialist and a member of the Correction Commission. The purpose of the meeting was to discuss the possibility of the Commission funding half of the salary to hire an Advocate Coordinator for the Commission on Crime, Delinquency and Correction. The other half of the funding is being requested from the City of Parkersburg. Commissioner Shaver stated that they would discuss and review their request and get back to them in January when they were working with the budget.

Also, on this the 18th day of December, 1980, the County Commission of Wood County upon the motion of Commissioner, William C. Parrish, seconded by Commissioner, Holmes R. Shaver, and made unanimous by Commission President, Marvin H. 
