

IN THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA

IN RE: Minutes of the Meeting held April 14, 1981

PRESENT: President, Holmes R. Shaver
Commissioner, William C. Parrish
Commissioner, Dexter L. Buckley, Jr.

At 10:00 a.m. the Commission witnessed an Incompetency Hearing alleging the competency of Eula B. Meredith. Upon hearing the testimony from various witnesses and the testimony from Dr. John Beane the Commission upon the motion of Commissioner William C. Parrish, seconded by Commissioner Dexter L. Buckley, Jr., and made unanimous by Commission President, Holmes R. Shaver unanimously agreed to declare Eula B. Meredith - Incompetent. It was further moved that Evelyn J. Meredith be appointed as committee to handle the profits or proceeds on behalf of Eula B. Meredith.

Also, the Commission approved an Inducement Resolution upon the motion of Commissioner William C. Parrish, seconded by Commissioner Dexter L. Buckley, and made unanimous by Commission President, Holmes R. Shaver as recommended by William Pfalzgraf - Bond Council and Elmer Blankman from the Wood County Development Authority, approved \$1,000,000.00 for the proposed expansion of the Mountain State Steel Foundaries, Inc. which will increase foundary capabilities and service to industry, acquire a machine shop operation and increase permanent employment by thirty (30) to forty (40) jobs.

Also, the Commission approved a Trust Indenture Agreement and Loan Agreement in the amount of 2.3 million dollars, by W.W. Motels Inc., for the acquisition of the Holiday Inn. Motion was

made by Commissioner William C. Parrish, seconded by Commissioner Dexter L. Buckley Jr., and made unanimous by Commission President, Holmes R. Shaver.

Also, the Commission witnessed the swearing in of Mr. David D. Hall, as a member of the Wood County Community Action Association.




