> PRESENT: President, Holmes R. Shaver Commissioner, William C. Parrish Commissioner, Dexter L. Buckley, Jr.

At 9:32 a.m. the Commission met with Sheriff, L. W. Bechtold to witness the swearing in of Mr. William F. Hoffman as a Deputy Sheriff for the Wood County Sheriff's Department.

At 11:00 a.m. the Commission held a street closing upon petition to close an unused street of which is a nortion of North Street, situate in Pineview Manner. After due consideration of the petition, this Commission found that the Petitioner, Charles A. Padgitt, Robert W. Friend, and Leslie C. Boysen, Trustees for the First Lutheran Church of Parkersburg, West Virginia, and the Defendants, Wade Gaston Dunn and E-len Anne Dunn, are all the owners of the property abutting upon said street which is sought to be closed and that there were no liens at the time said petition was filed. This Commission does further affirmatively find that so much of said street as is now sought to be closed, that being a portion of North Street lying westerly of the westerly line of Pine Avenue and running 150 feet between Lots 39 and 40 of Pine View Manor, is an unused road, not open and subject to public use, and that the use and rights of no persons, firms or corporations in such road will be impaired or lost by the closing. Attorney's representing the petitioners were Marian Lisa Yoke and Frank R. Yoke, Jr. Also, present was Mr. Wade Gaston Dunn (Defendant) stating his objection to being liable for any costs incurred

in regard to the street closing. Upon the motion of Commissioner William C. Parrish, seconded by Commissioner Dexter L. Buckley, Jr. and made unanimous by Commission President, Holmes R. Shaver it was ORDERED that the aforementioned street be closed. A copy of said ORDER is in attachment.
