

IN THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA

IN RE: Minutes of the Meeting held December 3rd, 1981

This day, the County Commission of Wood County, entered into a lease agreement with The Fraternal Order of Police Blennerhassett Lodge 79, Inc., WHEREAS, the Fraternal Order of Police Lodge 79, Inc., hereinafter referred to as LESSEE does hereby enter into a LEASE with the County Commission of Wood, hereinafter referred to as the Lessor, the following described premises, situate, lying and being in the County of Wood and State of West Virginia:

BEGINNING at an iron pipe in the northerly line of Summers Street, where said line interescts the easterly line of Mission Drive; thence with the easterly line of Mission Drive n-32° 10'E 88.08' to a pipe; thence leaving said Mission Drive S-55° 30'E 175.64' to a pipe in the westerly line of Johnson Street; thence with the westerly line of said Johnson Street S-34° 14'W 88' to a pipe at the northwesterly corner of Johnson and Summers Street N-55° 30'W 172'47' to the place of beginning, containing 0.352 Ac., more or less.

The lease shall be for a term of ninety-nine (99) years, commencing on the date of this Agreement, being the 3rd day of December, 1981, and ending on the 2nd day of December 2080, both dates inclusive, unless sooner terminated.

Under the terms of the lease, the LESSEE agrees to pay to the LESSOR the sum of One and 00/100 (\$1.00) per year, said rental payments to be made on the anniversary of the payment of

the first rental. Said lease is to be spread upon the records of this Commission.

Also, the Commission received one (1) 1981 Personal Property Tax Ticket to be impropered for a clerical error. The Commission received and approved the ticket and forwarded it to the Probate Office to be recorded. A copy of this ticket is in attachment.


