IN RE: Minutes of the Meeting held December 10, 1981

At 10:07 a.m. the Commission met with all elected officials to discuss personnel. The main purpose of the meeting was to introduce the fact that Circuit Clerk, Juanita Coe's need to hire another employee for her office due to the increase in work load. A possible solution was to see if any of the other officials would be willing to relinquish any funds for the hiring of another employee for her office. Commission President, Holmes R. Shaver stated that they were desperately looking for money to run the County with. In a past meeting with Ms. Coe the Commission informed her that they did not have the monies to hire any new personnel in the Court House.

This day came Joseph Carrico, Director of the Wood County Planning & Community Development Office and presented to the Wood County Commission a plat (Dearman Plat) consisting of three (3) lots in the Williams District, being the acquisition of 2.12 acres to Mrs. Lucille Myers, situate in the Williams District, and located on Route #2, North of Chichester. Upon the motion of Commissioner Dexter L. Buckley, Jr. and seconded by Commissioner William C. Parrish, and made unanimous by Commission President, Holmes R. 




No bond will be required for this subdivision of land.
