A letter was submitted to this Commission from Mr. Ray Cullem informing them of his resignation to the Wood County Parks and Recreation Board. The Commission accepted and approved said resignation and ordered that same be made a matter of record.




No bond will be required due to the fact that the property is accessible by the Pleasant Hill Road; therefore, no street improvements will be necessary.
