IN RE: Minutes of the Meeting held January 8, 1981

PRESENT: President, Holmes R. Shaver

At 10:55 a.m. the Commission met with Mr. Eddie Glasser, and Mr. Curtis Smith, from C.G.M. Contractors. The purpose of the meeting was to discuss the cost to construct a fire-proof room to store records which are presently being stored at the Parkersburg Transit Authority Bus Garage. Mr. Glasser stated to the Commission that the cost would be quite expensive. Glasser said the project could cost anywhere from 150,000.00 to 200,000.00. Mr. Glasser stated that the reason the project would be so expensive was because of the specifications that the room would have to meet. The Commission told the representatives that they would have to discuss the matter further and get back with them at a later date.






