IN RE: Minutes of the Meeting held July 7, 1981

PRESENT: President, Holmes R. Shaver
Commissioner, William C. Parrish
Commissioner, Dexter L. Buckley, Jr.

At 2:15 p.m. the Commission held a hearing to appoint council to handle the financial affairs of Mark E. Stump (whom has already been declared Incompetent by the Veterans Administration) a representative from the Wood County Bank was present during the hearing and agreed to act in the capacity of Fiduciary Committee to handle the financial affairs of the aforementioned Mark E. Stump. The County Commission unanimously agreed to appoint Wood County Bank to handle the finances.

At 3:07 p.m. the Commission met with Mr. Edward Lehew & Sandy Testa from Mountwood Park to discuss and review various financial disbursements made by the County to Mountwood Park.

Upon the motion of Commissioner William C. Parrish, seconded by Commissioner Dexter L. Buckley, Jr., and made unanimous by President, Holmes R. Shaver, it was ORDERED that the quotations received from Boso Equipment, Inc., 809 Camden Avenue, Parkersburg, WV 26101, for one (1) riding tractor, with mower, per specifications, be approved.
