


We appreciate your interest in Mountwood Park and have reviewed your letter of request for additional funds for the Park.

It has been brought to our attention again that you owe our five (5) months arrears in your lease obligation in relation to the nursing home facility at Cedar Grove.


For us to take any action as to the future lease, this past due account must be made current immediately.
