

IN THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA

IN RE: Minutes of the Meeting held July 21, 1981

PRESENT: President, Holmes R. Shaver
Commissioner, William C. Parrish
Commissioner, Dexter L. Buckley, Jr.

At 9:35 a.m. the Commission held an Incompetency Hearing, alledging the competency of Mr. Ross Wingrove. The Commission upon hearing the testimony of Dr. Robert Biddle and various other witnesses found the said Ross Wingrove to be declared Incompetent. There were also present two (2) persons present willing to handle the responsibilities and duties Mr. Roland Wingrove and Mr. Ross Charles Wingrove. Due to conflict between the two and pursuant to the wife and sons in agreement, agreed that Lisa Yoke, a discreet and competent attorney practicing at the Wood County Bar, be, appointed as committee for said incompetent and said committee was required to give bond, with good security, in the amount of \$20,000.00 dollars, all of which action was upon the motion of Commissioner Parrish, seconded by Commissioner Buckley, Jr., and made unanimous by Commission President, Holmes R. Shaver.

At 11:35 a.m. the Commission met with a representative from Honeywell. The purpose of the meeting was to discuss the heating system at the Wood County Correctional Center. The representative discussed and explained their Maintenance Agreement with the Commission and also discussed the renovation and repair to the original system. The represent^{ative}/went on to say that the cost would be approximately \$4,825.00 to repair the controls at the Center.

At 1:25 p.m. the Commission met with Mr. Curt Fulmer, Mr. Rodney Lynch, and Mr. Bill Summers from the Humane Society. The purpose of the meeting was to review their request for funding assistance with the Commission. The Commission stated that they were looking into the matter and would notify them as to their decision as soon as possible.

Also, the Commission met with Mr. Bob Hattman, from Hattman Glass to discuss the replacement of windows in the Wood County Court House. Mr. Hattman talked with the Commission in regard to the requirements of the windows. Mr. Hattman agreed that he would compile the specifications for the windows at no cost to the Commission. Mr. Hattman stated that he would be back in touch with the Commission within the following weeks with the specifications.
