

IN THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA

IN RE: Minutes of the Meeting held July 28, 1981

PRESENT: President, Holmes R. Shaver
Commissioner, William C. Parrish
Commissioner, Dexter. L. Buckley, Jr.

At 9:30 a.m. the Commission met with Attorney, George Shedan, (representing the Gor Corporation) and Attorney, Robert B. Black pursuant to a Notice served on Ernest Pauley, and Leo S. Pauley and said corporation to request that this Commission name and appoint three freeholders as disinterested arbitrators to arbitrate and settle a dispute which has arisen between the parties relating to the line fence. Thereupon, the Commission heard argument of counsel on the matters involved and after consideration the Commission found that a dispute has arisen between the parties involved; and that said parties cannot agree among themselves to the naming and appointment of three freeholders. It was therefore ORDERED upon the motion of Commissioner William C. Parrish, seconded by Commissioner, Dexter L. Buckley, Jr., and made unanimous by Commission President, Holmes R. Shaver that this Commission shall name and appoint three freeholders as disinterested arbitrators to arbitrate and settle the dispute which has arisen between both parties. Mr. Black, (representing the Pauleys) expressed his intention to appeal the findings and Order of this Commission to the Circuit Court of Wood County.






