IN RE: Minutes of the Meeting held June 16, 1981

PRESENT: President, Holmes R. Shaver
Commissioner, William C. Parrish

At 11:00 a.m. the Commission met with Attorney's Orville Hardman, Beryl Cunningham, and George Shedan. The purpose of the meeting was to hear the exceptions filed on claim for the Pearl L. Bonar Estate. Due to the fact the file was incomplete Mr. Hardman requested that they continue the matter until the file had been updated. The matter was rescheduled for Tuesday, June 23rd, 1981 at 11:00 a.m.

At 11:30 a.m. the Commission met with Mr. Mike Miller, Administrator, for the Ohio Valley Nursing Home. The purpose of Mr. Millers meeting with the Commission was to request a reduction in rent at the Nursing Home. Mr. Miller stated that he could not afford to pay \$1,600.00 per month for rent. Mr. Miller went on to say that he could only afford to pay \$400 or \$500 a month at the most. The Commission told Mr. Miller that they would have to discuss the matter with the Prosecutor and they would get back with him as soon as possible.

Also, the Commission met with Mr. Scott Morrison from the Department of Natural Resources and Mr. Fred Fields from the Soil Conservation Service. The purpose of the meeting was to discuss their proposal for two (2) boat landing sites. Mr. Morrison stated that they were looking for co-sponsors to work with the County Commission concerning the matter. Mr. Morrison

further stated that the cost would be shared by the Department of Natural Resources and the Little Kanawha Resource Conservation and Development. Mr. Morrision stated that they would present their plan to the Commission in approximately six (6) weeks.
