IN RE: Minutes of the Meeting held June 23, 1981

At 11:00 a.m. the Commission witnessed a hearing of Exceptions Filed on Claim in reference to the Pearl L. Bonar - Estate of which a final accounting of the estate was made by Mr. Richard M. Richmond. The Commissions findings on the matter were that the final reporting of Mr. Richard Richmond - Commissioner of Accounts was confirmed and the exceptions were over-ruled.

At 1:30 p.m. the Commission met with Mr. James Sheets, Director of the Wood County Health Department. The purpose of the meeting was to request funding assistance from the Wood County Mr. Sheets pointed out to the Commission that they Commission. had been receiving the same dollar amount from the Commission for the past four (4) years. Mr. Sheets pointed out that utilities and maintenance costs had absorbed the department's budget. Sheets further pointed out to the Commission that vacancies in personnel would not be filled because they did not have the funding. Mr. Sheets went on to say that he did not know where else to cut down other than personnel. It was also noted that the City of Parkersburg had given \$65,595.00 to the Health Department. Commissioner Parrish stated, "We are not generating enough tax payer dollars to help." Commission President, Holmes R. Shaver concluded the meeting by stating that they would certainly take

a look at their request in July when the Sheriff's budget balance was known.

Also, the Commission received various 1981 Personal Property Tax Tickets and Erroneous Assessments to be impropered for clerical errors. The Commission received and approved the tickets and forwarded them to the Probate Office to be recorded. Copies are in attachment.

A letter to all P.T.A.'s were sent out with a copy to the Sheriff which states that the Wood County Commission would not be responsible for suppling school crossing guards with uniforms.

Each school P.T.A. will be responsible for suppling said uniform.
