At 9:30 a.m. the Commission met with Attorney's Lawrence Ronning and Joseph Brown to discuss the easement over and across the property owned by Mr. Louis J. Balzano in relation to the Pond Run Project. Mr. Ronning suggested to the Commission that they have the land involved surveyed to have an overlay of the area. Also, Mr. Ronning announced their withdrawl as council for the Commission. Commissioner Parrish suggested the possibility of obtaining Prosecuting Attorney, Harry Deitzler to represent the Commission in the matter.

At 10:00 a.m. the Commission met with Mr. Curt Fulmer, Vice-President of the Humane Society to present the Commission with a report of services for 1980 to the present. Mr. Fulmer discussed and reviewed the services they provided to the County. Mr. Fulmer further stated that they had received \$800.00 from the Commission on a monthly basis for a number of years, and due to inflation they were requesting additional funding assistance from the Commission. The Commission told Mr. Fulmer that they would certainly consider their request and would let them know if they could help in any way.

Also the Commission held an Incompetency Hearing alledging the competency of Margaret Elizabeth Jones. The Commission upon hearing the testimony of Dr. O'Campo and various other witnesses to be declared Incompetent. A co-committee was appointed to handle the affairs of said Incompetent - Margaret Elizabeth Jones those appointed were Edward R. Jones and Harriett C. Turner. Bond was set in the amount of \$20,000.00.
