IN RE: Minutes of the Meeting held May 5, 1981

At 9:20 a.m. the Commission met with Mr. Edward Lehw, Director of Mountwood Park. Mr. Lehw met with the Commission to discuss monetary problems at the park, and also reported on the progress of the lake facilities.

At 10:00 a.m. the Commission met with Mr. Dominic Kim, A.I.A. Architect. Mr. Kim met with the Commission to discuss his proposal for adding on additional cells for female quarters at the Wood County Correctional Center. Mr. Kim quoted a rough estimate for the project at \$25,000.00 but would exclude the electronic controls and the camera. The Commission suggested that Mr. Kim talk with the Sheriff and review the proposal and get back with them.
