IN RE: Minutes of the Meeting held November 17, 1981

The Commission directed a letter to Mr. Walter Smittle III from the State Fire Marshal's Office advising him that the Commission was proceeding immediately with plans to install a sprinkler system in the Wood County Court House. The letter also states that they had been advised by one of the judges that he would not allow the installation of two (2) interior fire escapes as planned until the judicial system could be relocated. The letter stated that the Commission intended to brake ground on an annex in the spring of 1982. A copy of this letter is in attachment.

Also, the Commission accepted the quote of Stealey's Cleaners to clean the uniforms for the Sheriff's Deputies, at the rate of \$1.60 per suit and \$1.50 per jacket.
