

Dear Mr. Kim:

RE: Wood County Courthouse

Pursuant to our conversation of September 15, 1981, following is my understanding of the points agreed upon:

In order to comply with fire exit requirements, a fire tower will be constructed with exit occurring in the least obstrussive manner to the fascade of the building.

Existing windows will be replaced due to deterioration of the wooden members. Replacements will be fixed, aluminum with a center meeting rail to duplicate the appearance of the originals.

The color of the frames will be a light anodized firmish. This was determined due to concerns over maintenance and cost of an enamel coated frame. The new frames will be chosen to not contrast with the surrounding masonry.

Panes in the new windows are recommended to clear. The use of dark tinted panes is not recommended as these will alter the reflective qualities of the windows, thereby altering the character of the structure.

I hope that this is in agreement with your recollection. As discussed, I believe the program will not detract from the architectural qualities of the building. Feel free to call if there are questions.
