IN RE: Minutes of the Meeting held August 24, 1982

At 10:00 a.m. the Commission met with Mr. Larry Morehead, Mr. Howard Johe, and Mr. Earl Stephens, Architect. The purpose of the meeting was to discuss and review floor plans for the Court House Judicial Annex, and to request the Commission's approval. Mr. Morehead (developer) pointed out to the Commission that there were two (2) types of buildings that could be constructed. One of which Mr. Morehead pointed out would be in line with what the Commission had budgeted for expense wise and the other of which would be more expensive. Mr. Morehead suggested the Commission give this some thought and possibly consult with the Commission's Attorney, Mr. Pfalzgraf.

Also, Upon advertisement to bid to install a complete sprinkler system in the Wood County Court House, the following bids and quotations were received; Brewer & Company, in the amount of \$61,674.00 and Automatic Sprinkler, in the amount of \$82,765.00. Upon the motion of Commission President, Holmes R. Shaver, seconded by Commissioner Dexter L. Buckley, Jr., it was ORDERED that the aforementioned bids and quotations be held over for further discussion and review with disposition to be made at a later session of this Commission.

In other matters brought before this Commission, Mr. William Vaughan came before said Commission to object to the

proposed construction of a Courthouse Judicial Annex.
