

IN THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA

IN RE: Minutes of the Meeting held February 2, 1982

PRESENT: President, Holmes R. Shaver
Commissioner, William C. Parrish
Commissioner, Dexter L. Buckley Jr.

At 10:00 a.m. the Commission met with Mr. Robert L. Scalf, Parkersburg Public Works Director. The purpose of the meeting was to discuss a centralized garage for the City of Parkersburg to house their vehicles and gasoline. Mr. Scalf met with the Commission to see if they would be interested in sharing the building as well as the costs of the construction. Commission President, Holmes R. Shaver stated that at the present time the Commission's top priority was to build a Court House Annex. Mr. Shaver went on to say that the Commission may be interested in leasing at a later date.

At 11:00 a.m. the Commission witnessed a hearing of Guardianship Hearing. This day came the Petitioner, Marjorie Willey, in person and by counsel, H. F. Salsbery, Jr., the Respondent, Paula Willey, in person and with her Guardian-Ad-Litem, Richard A. Bush, and the Respondent's next of kin, other than the Petitioner, Helen Carr, in person. The Court, after having considered such Petition, the affidavits attached thereto, and the evidence introduced, did ORDER that Marjorie Willey be appointed as Guardian for Paula Willey and that such Guardian have such powers and duties as to the person and the estate of Paula Willey and as to any monies from any source that may be paid to such Guardian on behalf of Paula Willey as the law may allow or require. Further, that Marjorie Willey shall give bond, with corporate surety, in the amount of \$5,000.00, and all of the same was hereby ORDERED. Dated this the 2nd, 1982.
