At 10:00 a.m. the Commission met with Rev. Howard VanDyne. The purpose of the meeting with Rev. VanDyne was to to discuss and review an opening on the West Central West Virginia Community Action Board. Commissioner Parrish told Rev. VanDyne that several persons would be interviewed for the position, and they would be making a decision very soon.

Also, this day came the Petitioner, City of Vienna, a municipal corporation of Wood County, by counsel, and tendered the affadavit of publication and the affidavit of posting of notice for the Annexation of Property by Minor Boundary Adjustment.

Thereupon this matter came on to be heard upon the application of said Petitioner for a minor boundary adjustment to the City ov Vienna by the annexation of the territory in Williams District, Wood County, West Virginia. The Commission did find that the application is proper in all respects; and that notice was published and posted as required by law; and that the annexation of such territory as requested by the Petitioner constitutes and is a minor boundary adjustment as contemplated, and there is no opposition to such annexation, either substantial or otherwise, or to the proposed boundary change of the City of Vienna by such annexation; and that the application of the petitioner should be granted. It is further ORDERED that the territory hereinbefore described shall become and be a part of the City of Vienna, and within the corporate limits of the City of Vienna from and after the date of the entry of this Order.
