IN RE: Minutes of the Meeting held July 6, 1982

On this the 6th day of July, 1982, the Commission witnessed an Incompetency Hearing alledging the competency of Frances Marian Hawkins. Upon testimony and exhibits offered and admitted, the Commission found the said Frances Marian Hawkins, to be deleared incompetent by reason of her inability to manage her business affairs and care for her physical well being. The Commission upon consideration of the petition submitted by Jeanette Emerick accepted and approved said petition, to be appointed as Committee for Frances Marian Hawkins contingent upon the posting a bond in the amount of \$20,000.00.

Also, this day appeared William B. Richardson, Counsel for Mr. Jerry Russel Layner, guardian, for Barbara Lorraine Lammon, a minor. Pursuant to a petition filed asking the County Commission of Wood County, West Virginia, to relieve him as guardian of the Estate of Barbara Lorraine Lammon and to release his surety, Helen Core. Notice of this hearing was set for this the 6th day of July, 1982, at 2:00 p.m. before this Commission. The Court upon examining the report of the first and final settlement of Jerry R. Layner, Guardian for Barbara Lammon. The Commission ORDERED that Jerry Russell Layner be discharged as Guardian and surety signed by Helen Core be released subject to approval of the First and Final Settlement in the October term of the County

Commission of Wood County, West Virginia.






