Shaver, due to inadequate storage by virtue of the State Code of West Virginia the County Commission of Wood County has engaged the services of Mr. Clari A. Said employment shall be for a thirty (30) day period. To become effective July 8, 1982 at the rate of \$500.00 per month.





Said employment shall be for a thirty (30) day period. To become effective July 8, 1982 at the rate of #500.00 per month.


