IN RE: Minutes of the Meeting held July 13, 1982

PRESENT: President, Holmes R. Shaver

At 9:13 a.m. the Commission met with Mr. Gary Paschen, from Tri-State Roofing to discuss the H.V.A.C. System to be installed at the Court House.

At 10:00 a.m. the Commission witnessed an Incompetency Hearing alledging the competency of Ronald J. Morris. The Commission upon hearing the testimony and exhibits offered and admitted to record found the said Ronald J. Morris to be declared Incompetent. The Commission upon consideration of the petition submitted by Mary Louise Wise accepted and approved said petition to be appointed as Committee for Ronald J. Morris contingent upon the posting of a bond in the amount of \$10,000.00.

Also, the Commission met with Attorney, William R. Pfalzgraf. The purpose of the Mr. Pfalzgraf's meeting with the Commission was to enter an order authorizing the exercizes of the right of eminent domain. The Commission received and approved twelve such petitions. Copies are on file in the office of the Wood County Administrator, Sibyl Rowan, in the Wood County Court House.




