# IN THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA

IN RE: Minutes of the Meeting held June 3, 1982

PRESENT: President, Holmes R. Shaver Commissioner, William C. Parrish Commissioner, Dexter L. Buckley, Jr.

At 9:55 a.m. the Commission met with Mr. Ed Lehew, Director of Mountwood Park. The purpose of the meeting was to get the Commissions endorsement for a Grant Application for funds in regard to Heritage Conservation and Recreation Service Urban Park and Recreation Recovery Program for Mountwood Park White Oak Village. The grant application for funding assistance was in the amount of \$170,688.00. Federal Share - \$145.085.00, State Share \$25,603.00.

At 11:30 a.m. the Commission met with Mr. George Fox Director, of the Wood County Emergency Services. Mr. Fox presented the Commission with a copy of a letter of which he had received from Mr. Cecil H. Russell, Director of the State Office of Emergency Services in Charleston. The letter states that Ken Edwards (FEMA Region III) and Tom Burns (WVOES) had advised him (Mr. Russell) their findings concerning the development of Emergency Service Office. The letter points out that FEMA does not recommend developing the E.O.C. at the present site (Staunton Avenue) due to prohibitive costs involved. The letter goes on (Emergency Operation Center) to suggest that the E.O.C. be developed in the proposed Courthouse Upon reading the letter Commissioner William C. Parrish Annex. suggested a meeting with the Parkersburg City Council and the Wood County Commission as well as Mr. Fox. A meeting is slated for Tuesday, June 3th, at 3:30 p.m.
