IN THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA IN RE: Minutes of the Meeting held May 4, 1982

> PRESENT: President, Holmes R. Shaver Commissioner, William C. Parrish Commissioner, Dexter L. Buckley, Jr.

At 9:00 a.m. the Commission met with Mr. Rodney Lynch, Shelter Manager for the Humane Society and Mr. Curt Fulmer, Vice-President of the Humane Society. The topic under discussion was a proposed Dog Ordinance for Wood County. The Commission stated that they were going to review other Dog Ordinances before any finalization was reached. Prosecuting Attorney, Harry G. Deitzler agreed to write the Ordinance up in legal form as soon as an agreement had been reached.

Also, upon advertisement to bid to furnish and install labor and materials for an H.V.A.C. (Heating, Ventilation and Air Conditioning for the Wood County Court House, the following bids and quotations were received; Young. Plumbing & Heating, to furnish labor and equipment to remove heating equipment from the Court House in the amount of \$14,909.00, the next bid received was from Morrison, Inc., to furnish labor and equipment to install H.V.A.C. System, in the amount of \$163,771.00, the next bid was from Steers Heating Company, to furnish labor and equipment to install H.V.A.C. system in the Court House in the amount of \$179,500.00 and to furnish labor and equipment to remove existing heating equipment in the Court House, in the amount of \$14,500.00 the next bid received was from Tri-State Roofing & Sheet Metal Co., to furnish labor and equipment to install H.V.A.C. system in the amount of \$167,500.00. Upon the motion of Commissioner William C. Parrish, seconded by Commissioner Dexter L. Buckley, Jr., and made unanimous by Commission President, Holmes R. Shaver it was ORDERED that the aforementioned bids and quotations be held over for further discussion and review with disposition to be made at a later session of this Commission.

At 1:30 p.m. the Commission met with Mr. Paul Florence, Rev. W. K. Westfall and Mr. Vance Crites from Wood County Farm Bureau. The purpose of the discussion was to discuss the problems with dogs out in the county. The Commission assured the group that no decision had been reached as of yet, and they gave the representatives a copy of the proposal to look over for their comments.
