

IN THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA

IN RE: Minutes of the Meeting held October 14, 1982

PRESENT: President Pro-Tem, William C. Parrish

The Commission met with Mrs. Judy Parrish, and Ms. Barbara Dickison, representatives from the Vienna Women's Club. The purpose of the meeting was to discuss certain property situate at the lower end of 32nd Street and located near the Jackson Park and Jackson Jr. High. Ms. Dickison stated that this property had been placed on the ballot and the bond levy had been defeated. Ms. Dickison went on to say that it was their intention to stop re-zoning and get the property changed from residential to commercial. Ms. Dickison stated that they would like to work with Mr. Perry who is the property owner to develop something that is compatible to both the school and the park. The Commission suggested that the group meet with the Vienna City Council to discuss this matter. The Commission further pointed out as a possible avenue that the group seek out private monies or contributions to purchase the property.

Also, the Commission met with Dr. Martin Garino from the Western District Guidance Center. The purpose of the meeting was to clarify the bills that the Western District Guidance Center had sent to the Commission for psychiatric examinations for the prisoners incarcerated in the Wood County Correctional Center. The Commission pointed out that they contributed every year the amount of \$39,100,00 to the Center, and to be used for this purpose.

The Commission also received various 1982 Erroneous Assessments to be impropered for clerical errors. The Commission received and approved the Assessments and forwarded them to the Probate Office to be recorded. Copies are in attachment.

Purchase Order #6496, to Sears Roebuck & Co., in the amount of \$14.94, for the Maintenance Department.


Purchase Order #6497, to Casto & Harris, in the amount of \$28.00, for the County Clerk's Office.

Purchase Order #6498, to H & I Wholesale, in the amount of \$70.82, for the Correctional Center.


