The Commission witnessed the swearing in of Mr. Charles A. Townsend, as a member of the Claywood Park Public Service District.

Also, the Commission held a hearing in regard to a street closing situate in Bethel Place. The petition was filed by Mr. Steers of Steers Heating. Upon hearing the testimony of Mr. Steers and various other witnesses present the Commission unanimously agreed to deny the petition to close the street. Commission President, Holmes R. Shaver pointed out that the matter had come before the Commission before and that they had ruled against it.






